ORDINANCE No. 14 - 01

DATE: February 18, 2014

INTRODUCED BY: Public Peace and Good Order Committee

SYNOPSIS: Creating and Enacting Section 9.411 of the Juneau County Code of Ordinances

WHEREAS, The County has been requested by Mauston Police Chief Mark Messer and Mauston Police Officer Andy Zobal, who works primarily in the Mauston Public Schools, to enact an ordinance that will adopt Wis. Stats. § 947.0125, entitled "Unlawful Use of Computerized Communication Systems," into the Juneau County Code of Ordinances in order to provide a prosecutorial alternative to police and law enforcement officials for acts which otherwise would be violations of state law, and such an ordinance will be useful in dealing with problems of misuse of computers by minors in and out of school throughout Juneau County; and

WHEREAS, the proposed Section 9.411 of the Juneau County Code of Ordinances entitled *Unlawful use of computerized systems*, a true copy of which is attached to this resolution, is a proper and complete codification, the law contained in Wis. Stats. § 947.0125;

NOW, THEREFORE BE IT ORDAINED that the Juneau County Board of Supervisors shall and hereby does create and enact § 9.411 of the Juneau County Code of Ordinances entitled *Unlawful use of computerized systems*, a true copy of which is attached to this resolution, to read as provided in the attached addendum.

9.411 Unlawful use of computerized communication systems.

- (1) In this section, "message" means any transfer of signs, signals, writing, images, sounds, data or intelligence of any nature, or any transfer of a computer program, as defined in Wis. Stats. s. 943.70 (1)
 - (2) Whoever does any of the following is guilty of a forfeiture offense:
- (a) With intent to frighten, intimidate, threaten, abuse or harass another person, sends a message to the person on an electronic mail or other computerized communication system and in that message threatens to inflict injury or physical harm to any person or the property of any person.
- (b) With intent to frighten, intimidate, threaten, abuse or harass another person, sends a message on an electronic mail or other computerized communication system with the reasonable expectation that the person will receive the message and in that message threatens to inflict injury or physical harm to any person or the property of any person.
- (c) With intent to frighten, intimidate, threaten or abuse another person, sends a message to the person on an electronic mail or other computerized communication system and in that message uses any obscene, lewd or profane language or suggests any lewd or lascivious act.
- (d) With intent to frighten, intimidate, threaten or abuse another person, sends a message on an electronic mail or other computerized communication system with the reasonable expectation that the person will receive the message and in that message uses any obscene, lewd or profane language or suggests any lewd or lascivious act.
- (e) With intent to frighten, intimidate, threaten or abuse another person, sends a message to the person on an electronic mail or other computerized communication system while intentionally preventing or attempting to prevent the disclosure of his or her own identity.
- (f) While intentionally preventing or attempting to prevent the disclosure of his or her identity and with intent to frighten, intimidate, threaten or abuse another person, sends a message on an electronic mail or other computerized communication system with the reasonable expectation that the person will receive the message
- (g) With intent to harass, annoy or offend another person, sends a message to the person on an electronic mail or other computerized communication system and in that message uses any obscene, lewd or profane language or suggests any lewd or lascivious act.
- (h) With intent to harass, annoy or offend another person, sends a message on an electronic mail or other computerized communication system with the reasonable expectation that the person will receive the message and in that message uses any obscene, lewd or profane language or suggests any lewd or lascivious act.
- (i) With intent solely to harass another person, sends repeated messages to the person on an electronic mail or other computerized communication system.
- (j) With intent solely to harass another person, sends repeated messages on an electronic mail or other computerized communication system with the reasonable expectation that the person will receive the messages.

- (k) With intent to harass or annoy another person, sends a message to the person on an electronic mail or other computerized communication system while intentionally preventing or attempting to prevent the disclosure of his or her own identity.
- (L) While intentionally preventing or attempting to prevent the disclosure of his or her identity and with intent to harass or annoy another person, sends a message on an electronic mail or other computerized communication system with the reasonable expectation that the person will receive the message.
- (m) Knowingly permits or directs another person to send a message prohibited by this section from any computer terminal or other device that is used to send messages on an electronic mail or other computerized communication system and that is under his or her control.
- (3) This section is consistent with and an adoption of Wis. Stats. s. 947.0125 and is intended to provide a prosecutorial alternative for acts which may otherwise be violations of state law. Penalties for violations of this section are as provided in Code of Ordinances s. 9.49 below.

SYNOPSIS: Approval of a Settlement Agreement in an Employment Dispute and Authorization for County Officials to Sign the Agreement as the Official Act of Juneau County

WHEREAS, the Juneau County Corporation Counsel has negotiated a proposed settlement of the County's pending employment dispute with Joshua Czys, a former employee of the County Sheriff's office, which is currently in arbitration before a Wisconsin Employment Relations Commission arbitrator, and he recommends that the County accept the proposed settlement agreement, the terms and conditions of which are set forth in a copy of the Settlement Agreement attached hereto;

WHEREAS, the Juneau County Board of Supervisors has discussed the proposed agreement with the Corporation Counsel in closed session and has heard and considered his reasons for recommending that it be accepted and entered into by the County; and

WHEREAS, the County Board finds that the proposed agreement properly provides that the County does not admit to any liability and asserts that there has been no wrongdoing by the County or its officers or employees and, nonetheless, finds that the agreement is fair and reasonable and is in the best interests of Juneau County as a prudent act of expedience because the settlement amount is small compared to the cost to the County of litigating and winning an outright dismissal of the claim;

NOW, THEREFORE, BE IT RESOLVED, that the Juneau County Board of Supervisors shall and hereby does approve of and accept said agreement and does hereby authorize County Board Chairman Alan K. Peterson to duly execute the original Settlement Agreement forthwith, as the official act of Juneau County.

SETTLEMENT AGREEMENT

The parties to this agreement are Josh Czys and the County of Juneau, Wisconsin, acting through its Board of Supervisors.

This settlement agreement is made effective upon the last to occur of the signatures of the parties below, and approval by the Juneau County, Wisconsin Board of Supervisors. If the Juneau County Board of Supervisors fails to approve this agreement by March 1, 2014, it shall be void.

BACKGROUND

- A. Mr. Czys has filed a claim alleging that the County of Juneau, Wisconsin violated his legal rights by failing to accommodate his epilepsy. He seeks damages for personal physical injuries sustained during a seizure at work and for lost wages and benefits.
- B. The County of Juneau, Wisconsin denies that there is any merit to Joshua Czys' claims and further denies that it has violated his rights or treated him unlawfully in any way.
- C. William M. Cunningham has served as legal counsel to Joshuz Czys in connection with these claims.

AGREEMENT

1. Payment

- A. The County of Juneau will pay to Joshua Czys the sum of Eleven thousand Dollars (\$11,000) to compensate him for personal physical injuries sustained arising from a seizure at work on February 1, 2012.
- B. The County of Juneau will pay to Joshua Czys the sum of Two thousand Dollars to compensate him for lost earnings, subject to deductions for income and employment taxes.
- C. The County of Juneau will pay to William M. Cunningham the sum of \$4,000.
- 2. <u>Tax Reporting.</u> For purposes of Federal and Wisconsin income tax reporting, the County of Juneau will provide Joshua Czys with a W-2 form for the year 2014 reflecting employee wages of \$2,000, together with all amounts withheld for state and federal income taxes, and FICA and Medicare withholding. The County of Juneau will not issue a Form 1099 for the Eleven thousand Dollars paid to compensate Mr. Czys for his claimed personal physical injuries, in accordance with the federal instructions to Federal form 1099. The County of Juneau will issue Attorney William Cunningham a Federal Form 1099 for the year 2014 in the format as the Form 1099 attached to this agreement, which is incorporated by reference.
- 2. Release of Claims. Joshua Czys and his heirs, successors and assigns, agrees to release the County of Juneau, together with the County's employees, agents and officers from any claims arising any time before the parties sign this agreement. This Release, however, does not waive Joshua Czys' right to benefits under any worker's compensation law, vested retirement benefits or rights under this agreement.

SYNOPSIS: Authorizing County Officials To Convey Title To The Vacant Land Owned By The County At Or Near The County Fairgrounds In Mauston To The Juneau County Agricultural, Industrial And Recreational Society, Inc. (JCAIRS)

Fiscal Note: No Additional Cost to the County

WHEREAS, Juneau County currently leases to the Juneau County Agricultural, Industrial And Recreational Society, Inc. (JCAIRS) the 36.11 acre tract identified as Lot 1 of Certified Survey Map 3738, as recorded in the office of the Juneau County Register of Deeds in Volume 16, Page 123, as Document 653436, in Part of the SW¼ of the NE¼ and Part of the NW¼ of the SE¼ in Section 13, T15N, R3E, in the City of Mauston, County of Juneau, Wisconsin, by virtue of a Vacant Land Lease dated August 1, 2008 and recorded on August 1, 2008 as Document No. 667741 in the office of the Juneau County Register of Deeds; and

WHEREAS, it is in the best interests of the County that it have no further responsibility for or liability regarding said real estate as it is managed and used by JCAIRS for the good of the people of Juneau County and the City of Mauston, and the public generally, and JCAIRS is in need of capital assets to assist in obtaining funding for its activities now and in the future; and

WHEREAS, JCAIRS and the City of Mauston are prepared to guarantee that said real estate shall be used for the benefit of the annual Juneau County Fair and that the Juneau County Fair shall continue to be held annually at the Juneau County Fairgrounds currently located on or near said real estate in the City of Mauston; and

WHEREAS, JCAIRS agrees to allow Juneau County to have and retain title to whatever soil is removed from the premises for the anticipated construction by JCAIRS, or others on its behalf, of a holding pond on said real estate, which is anticipated to be approximately 2,800 cubic yards of topsoil and subsoil;

NOW, THEREFORE, BE IT RESOLVED, that the Juneau County Board of Supervisors shall and hereby does approve and authorize the County to convey title to the aforesaid vacant land owned by the County to the Juneau County Agricultural, Industrial and Recreational Society, Inc. (JCAIRS), provided that (1) the deed of conveyance shall contain a restriction requiring that the property be used for the benefit of the annual Juneau County Fair and that the Juneau County Fair shall continue to be held annually at the Juneau County Fairgrounds currently located on or near said real estate in the City of Mauston, and further providing that, in the event that JCAIRS ceases to exist, title to the property shall revert to Juneau County, (2) the City of Mauston provides written assurance to the County that it agrees to and shall abide by the terms of said deed restriction, and (3) JCAIRS agrees to allow Juneau County to have and retain title to whatever soil is removed from the premises for the anticipated construction by JCAIRS, or others on its behalf, of a holding pond on said real estate, which is anticipated to be approximately 2,800 cubic yards of topsoil and subsoil; and

BE IT FURTHER RESOLVED, that Juneau County Board Chairperson Alan K. Peterson and Juneau County Clerk Kathleen C. Kobylski shall be and hereby are authorized to duly execute the documents necessary to complete the transaction, when they are approved by the Juneau County Corporation Counsel, as the official act of Juneau County.

WHEREAS, the ad hoc committee comprised of members of the Negotiating Committee, Executive Committee, Personnel Committee, and Finance Committee, which is responsible for the County's new Personnel Policy that became effective January 1, 2014, has determined that there is a need to amend Section 8.1, entitled Sick Leave, in Chapter 8, entitled Leave Policies, on page 27 of the new policy to clarify ambiguities therein and to clearly effectuate the intent of the ad hoc committee and the Juneau County Board of Supervisors in enacting said policy; and

WHEREAS, the changes proposed by the ad hoc committee are set for on the attached addendum, showing the specific amendments and stating in final form how the amended provision shall read as a whole, and the ad hoc committee and the Executive Committee request that the entire County Board adopt the proposed amendments forthwith;

NOW, THEREFORE, BE IT RESOLVED, that the Juneau County Board of Supervisors shall and hereby does approve, authorize, and adopt the proposed amended § 8.1 of Chapter 8 on page 27 of the new Juneau County Personnel Policy, as set forth in the attached addendum to this resolution, to be effective retroactively as of January 1, 2014 and continuing thereafter, until and unless it is modified, amended, terminated, or otherwise affected by further action of the County Board in the future.

CHAPTER 8 - LEAVE POLICIES

8.1 SICK LEAVE

Is amended as follows:

All regular full time employees shall earn one day of sick leave per month rendered in service. They shall earn four (4) hours of sick leave per two-week pay period. The four hours will accumulate for twenty-four pay periods each year; equal to twelve (12) sick days earned per year.

The maximum accumulation for any regular full-time employee shall be one hundred-twenty (120) days. Regular part-time employees shall receive sick leave on a pro-rated basis. Any accrual of over 120 days of sick leave shall go into a catastrophic sick leave account; accrued at the rate of one half (½) a day a month. Catastrophic sick leave is accrued in the event a severe illness necessitates the utilization of the employee's entire sick leave balance. When a sick leave account is completely exhausted, the employee may begin utilizing the sick leave accrued in the catastrophic sick leave account. When the employee is able to return to work and their his or her sick leave balance is less than 120 days, the employee will return to accruing sick leave in full day increments to restore the sick leave account balance to the maximum of 120 days. With the balance reestablished to the maximum of 120 days, any sick leave beyond the 120 days will accrue the sick leave accrual will return to one half (½) day increments to add to the catastrophic sick leave be paid out.

Those employees who have accumulated more than 120 days prior to January 1, 2014 may be allowed to keep that accumulation, provided that any additional hours received accumulated after January 1, 2014thereafter will shall not be credited only to the counted (other than for catastrophic sick leave accumulation,) until and unless that employee's balance falls below 120 days. If there is an initial accumulation of more than 120 days that has been "grandfathered in," days of sick time for that employee will be deducted from his or her total that exceeds 120 days. If that total is depleted to below 120 days, sick days may accumulate again up to 120 days before they then are credited only as catastrophic sick days.

So that the final version shall read as follows:

8.1 SICK LEAVE

All regular full time employees shall earn one day of sick leave per month rendered in service. They shall earn four (4) hours of sick leave per two-week pay period. The four hours will accumulate for twenty-four pay periods each year; equal to twelve (12) sick days earned per year.

The maximum accumulation for any regular full-time employee shall be one hundred-twenty (120) days. Regular part-time employees shall receive sick leave on a pro-rated basis. Any accrual of over 120 days of sick leave shall go into a catastrophic sick leave account. Catastrophic sick leave is accrued in the event a severe illness necessitates the utilization of the employee's entire sick leave balance. When a sick leave account is completely exhausted, the employee may begin utilizing the sick leave accrued in the catastrophic sick leave account. When the employee is able to return to work and his or her sick leave balance is less than 120 days, the employee will return to accruing sick leave in full day increments to restore the sick leave account balance to the maximum of 120 days. With the balance reestablished to the maximum of 120 days, any sick leave beyond the 120 days will accrue to the catastrophic sick leave account. In no event shall catastrophic sick leave be paid out.

Those employees who have accumulated more than 120 days prior to January 1, 2014 may be allowed to keep that accumulation, provided that any additional hours accumulated after January 1, 2014 shall be credited only to the catastrophic sick leave accumulation, until and unless that employee's balance falls below 120 days. If there is an initial accumulation of more than 120 days that has been "grandfathered in," days of sick time for that employee will be deducted from his or her total that exceeds 120 days. If that total is depleted to below 120 days, sick days may accumulate again up to 120 days before they then are credited only as catastrophic sick days.




