

Juneau County Sheriff's Committee Meeting Minutes

September 10, 2019 at 8:30 am

Meeting was called to order by Lynn Willard

Motion by Feldman, seconded by Willard to approve August 2019 minutes

Motion by Willard, seconded by Feldman to approve August 2019 vouchers

- August Overtime – Los Dells added greatly to the August overtime. We will be reimbursed \$36,297 from Los Dells plus \$2,484.545 from Lyndon Station Park Days.
- Shotgun Purchases – We received a quote from Kiesler Police Supply for 2 Remington 12ga shotguns for 481.00 each. Total price of \$975.00 including shipping. This is to come from the firearms/ammunition budget. Motion made by Feldman and seconded by Willard to purchase 2 shotguns for a total price of \$975.00 from the firearms budget.
- Breaching Equipment - We have a quote for \$7860.00 for the purchase of explosive breaching equipment. We have \$7000.00 budgeted for this. The extra to come from the firearm budget. Motion made by Willard and seconded by Feldman to purchase the breaching equipment.
- Snowmobile – Our current snowmobile is 15 years old. We had put money into it last year. We got two quotes for SkiDoo 600s. Vetesnik's came it at \$9,344 with our trade in. Jay's quoted \$9245 without a trade in. We got a quote for a Polaris 600 from Mittelstaedt's for \$9,655 without a trade in. We get a cost reimbursement from the DNR of 20% a year for 5 years each. Motion made by Feldman and seconded by Willard to approve the purchase from Jay's Power Center in Reedsburg and to sell our old snowmobile outright.
- Body Camera Licenses – We had received a quote from Provision for 5 year software licensing of \$475.00 each. We had originally purchased the licenses for \$315 each when we got the bodycameras. Funds to come from inmate account. New quote received by Captain Beier for \$300.00 each. Motion made by Willard and seconded by Feldman to approve the purchase of 5 software licenses not to exceed \$1,600
- Transport Van – Purchase a transport van from Kudick's for \$19,000. We were approved to spend up to \$20,000 so the remaining \$1,000 will go towards the fitting of a new cage for the van.
- Budget – Motion made by Willard and seconded by Feldman to approve the 2020 budget and send it to finance.

Motion made by Willard and seconded by Niles to adjourn the meeting.
