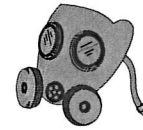
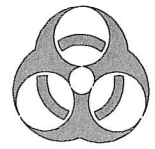

### E. Old Business

1. **WISCOM Radio System Update** – All law enforcement radios have been reprogrammed with the latest firmware and law enforcement code plugs. Training was held for law enforcement and dispatchers on October 1 & 3, 2019. The radio system was switched over to the trunked system for law enforcement in November 2019, but due to frequency licensing issues law enforcement was switched back to the analog system until the frequency licensing is completed.
2. **Grants for Juneau County Update** – Four (4) Grants were applied for:
  - 1) Juneau County Computer/Hazmat Grant 2019 - \$10,000.00  
Awarded grant amount of \$7,197.60  
Equipment has been ordered and received. Close out of the grant was on December 15, 2019.
  - 2) Adams County Computer/Hazmat Grant 2019 - \$10,000.00  
Awarded grant amount of \$7,269.80  
Equipment has been ordered and received. Close out of the grant was on December 15, 2019.
  - 3) HMPG EM Performance Grant Award 2020 - \$34,296.00
  - 4) EPCRA Planning Grant Award 2020 - \$10,883.00
  - 5) Applied for Exercise Grant to test the “Juneau County Emergency Response Plan” in 2021 - \$21,137.56
3. **Homeland Security Active Shooter Exercise Grant** – A Functional Exercise was held on October 2, 2019 0900 – 1200 at the Lodge in Mauston. The exercise focused on an active shooter within the Mauston School District. The exercise involved: response agencies coordination and communication with the school district, command structure, roles and responsibilities, current plans and procedures, response operations and reunification.
