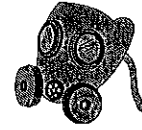
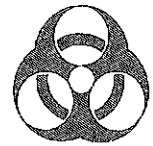

E. Old Business

1. **WISCOM Radio System Update** – The radio system was switched back over to the VHF conventional analog system for law enforcement in November 2019, and is still waiting for frequency licensing for the north cell of the trunking system from the State Frequency Coordinator and the FCC.

3. **Homeland Security Active Shooter Exercise Grant** – Initial Planning Meeting was held on January 28, 2020 1000 – 1200 at the Justice Center. The planning meeting focused on response agencies coordination, responsibilities and communication with the school district, command structure, current plans and procedures, response operations and reunification of parents and students. The Full Scale Exercise is scheduled for June 11, 2020 at the Mauston High School.

Reimbursement has been received for the TX (Tabletop) and FX (Functional) Exercises in the amount of \$11,851.98

6. **Flooding Issues in Clearfield Township & Northern Juneau County** – "Juneau County Flood Management Plan Study" with the U.S. Army Corps of Engineers, Wood County Emergency Management, Juneau County Land & Water Resources, Juneau County Emergency Management Necedah Township, Clearfield Township and Cutler Township is continuing. Nothing new to report at this time.

7. **Hazmat Team Report** – New member contacts were made by Gervase and additional members are still needed for the team.

8. **Flooding County-Wide August 29-30 through September 14, 2018** – The "Long Term Flood Recovery" Group continues to assist residents in Juneau, Monroe, Adams and Waushara Counties. A meeting held by the recovery group on January 28, 2020. "Project Recovery" has made contact with 24,000 people in nine counties, the program ended November 15, 2019. FEMA and WEM are still working on missing information and reimbursement to some townships, villages and cities in the county.
