 4. FSA – Sarah Fleck
 - We have a COVID-19 relief program available to timber harvesters and haulers. Timber brokers are not eligible to apply. If there are any interested producers, they can call the FSA office to review program eligibility and what the application requirements entail
 - Reminder to all producers that plant fall crops, including cover crops. Fall crop reporting deadline is November 15th. We will accept crop reports for any fall seeded crops after that producer has planted, but no later than November 15th
 - CRP participants are reminded to read their contracts, conservation plans and any other documentation carefully and follow instructions. The county office staff is available for administrative assistance, but we are not the ones out in the country doing the work or purchasing seed, etc.
