 - Update given on January vouchers, discussion of USGS/Sauk stream monitoring payments
- 4. NRCS Jon Field
 - EQIP signup needs to be submitted by Feb. 11th. 32 applications have been submitted
 - Summary of EQIP practices such as cover crops, converting cropland, and grazing easements
- FSA Jim Raese
 - Doors are still locked due to Covid-19, call to schedule an in-person meeting
 - ARCPLC 2022 program sign up is underway. The recommendations are out from the UW-Madison specialist. The sign-up deadline is March 15th, 2022.
 - The Dairy Margin Coverage program sign up is well underway. The sign-up deadline has been extended to February 25th, 2022.
 - We currently have a General CRP underway. The General CRP offers will be accepted by the FSA offices from January 31st, 2022, through March 11th, 2022. For General CRP sign up offers, all the offers are sent in nationwide and then decided via the National FSA standards and points at that time if the acres/offer will be accepted for rent by USDA
 - There is also Continuous CRP sign up available through FSA. This sign-up will start after April 1st, 2022.
