- 4. Incarcerated Veteran Program Colin was on this committee, but now he is on the CVSO Accreditation Program. He still does zoom meetings with incarcerated Veterans once a month, these meetings have been better versus going to the facilities to meet with them. He doesn't have internet access, and the Wi-Fi doesn't always work. The Veteran representative at those facilities set up the zoom meetings with Colin and Veteran.
- 5. Colin handed out the Camp American Legion pamphlet from the Conference. Once they get lined up, will get one each week. Most expenses would be paid for.
- 6. Colin shared with the Committee the Purple Heart Newsletter email.
