Visiting rules and regulations

The visiting process is governed by the following rules and regulations. Any violation of the rules and regulations by a visitor may result in the end of the visit, and the visitor will be required to leave the facility. If the visitor engages in unlawful conduct, he/she is subject to arrest. Violation of the rules and regulations or infractions of the law may result in the visitor having privileges suspended or permanently revoked. For the safety and security of the jail, visits may be denied/terminated at anytime.

1. Visitors are not allowed to carry cameras, tape recorders, purses, bags, briefcases, cell phones, baby strollers/carriers or any other items into the visiting areas. Personal items should be left at home or locked in the visitor's vehicle. Items may also be locked in the public lockers located in the lobby area. Items not reclaimed by visitors at the conclusion of visiting will be removed and disposed of. The Juneau County Sheriff's Office is not responsible for lost, stolen, damaged, or removed items.
2. Bringing firearms, explosives, alcoholic beverages, narcotics, or any controlled substance into the facility is a crime, and the visitor will be subject to arrest. (WI Statute 302.095)
3. Any visitor under the influence of alcohol or drugs will not be allowed to visit and may be subject to arrest.
4. Visitors and their possessions are subject to search by Sheriff's Office personnel. **Upon entering the Juneau County Jail Public Visiting Area, you are consenting to a pat-down search at any time by a Juneau County Deputy Sheriff.**
5. Smoking is prohibited inside or within 75 feet the Juneau County Justice Center.
6. **No food or drink is permitted in the visiting areas.**
7. All visitors are required to proceed directly to their respective visiting areas and to remain there until their visit is completed. Upon completion of the visit, the visitors must leave the facility. At any time, the visitor may terminate the visit and return to the lobby. Visits will last approximately sixty (60) minutes with each visitor. You will not be given extra time if you arrive early. If you arrive after your scheduled time, you will be allowed only the remainder of the allotted hour.
8. Visitors and inmates are to refrain from loud talking or any disruptive behavior. Visitors with disruptive children may have their visit terminated. Children **must** be supervised and controlled by an adult at all times.
9. When the lights flash, your visit is over.
10. An inmate may refuse to see any visitor.
11. **Any** discourteous acts will immediately terminate your visit.

PLEASE FOLLOW THE FOLLOWING PROCEDURE:

- Money deposits may be made by mail or in person. Only cash, money orders, payroll or tax refund/gov't checks will be accepted for deposits on inmate's accounts. No personal checks will be accepted. Do not send cash through the mail. If depositing money in person, you must have the exact amount. **NO CHANGE WILL BE GIVEN.**
- Visitors may be required to produce valid photo identification (driver's license, military, etc.) before visiting an inmate or depositing money on the inmate's account. Failure to provide valid photo identification will result in your visit being cancelled. **No visitors under the age of 18 allowed unless accompanied by a parent/guardian.**
